

ORDINANCE NO. 2009-001

**AN ORDINANCE AMENDING THE PALATINE RURAL
FIRE PROTECTION DISTRICT ORDINANCE #2006-001
(CHARGES FOR EMERGENCY MEDICAL SERVICES)**

WHEREAS, the Palatine Rural Fire Protection District (the “District”), is a fire protection district duly organized under the laws of the State of Illinois; and

WHEREAS, the Board of Trustees of the District has full power to pass all necessary ordinances, and rules and regulations for the proper management and conduct of the business of the Board of Trustees of the District for carrying into effect the objects for which the District was formed under 70 ILCS 705/6; and

WHEREAS, on March 11, 2002, the Board of Trustees adopted its Ordinance 2002-02 entitled “An Ordinance Establishing a Schedule of Charges for Emergency Medical Services for the Palatine Rural Fire Protection District”; and

WHEREAS, on December 9, 2002, the Board of Trustees adopted its Ordinance 2002-12 entitled “An Ordinance Amending Ordinance 2002-02 Charges for Non-Resident Emergency Medical Services”; and

WHEREAS, on December 9, 2002, the Board of Trustees adopted its Ordinance 2002-13 entitled “An Ordinance Establishing a Schedule of Charges for Emergency Medical Services Rendered by the Palatine Rural Fire Protection District to District Residents”; and

WHEREAS, on March 13, 2006, the Board of Trustees adopted its Ordinance 2006-001 Entitled “An Ordinance Amending the Palatine Rural Fire Protection District Ordinance 2006-001 (Charges For Emergency Medical Services).”

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Palatine Rural Fire Protection District, Cook County, Illinois, as follows:

Section One: The Board of Trustees hereby amends its Ordinance 2006-001 by amending the fee schedule for Non-District residents to read as follows:

Non-District Residents

Treat/Non-Transport Base Rate	\$ 200.00
BLS Emergency w/ Transport	\$ 945.00
ALS 1 Emergency w/ Transport	\$1,115.00
ALS 2 Emergency w/ Transport	\$1,350.00
Mileage	\$ 10.00

Section Two: The Board of Trustees hereby amends its Ordinance 2006-001 by amending the fee schedule for District residents to read as follows:

District Residents

Treat/Non-Transport Base Rate	\$ 100.00
BLS Emergency w/ Transport	\$ 700.00
ALS 1 Emergency w/ Transport	\$ 825.00
ALS 2 Emergency w/ Transport	\$1,000.00
Mileage	\$ 10.00

Section Three: All revenue from the charges assessed pursuant to this Ordinance shall be deposited in the Ambulance Fund of the Palatine Rural Fire Protection District.

Section Four: The Fire Chief may, at his discretion, waive the costs and/or fees due under this Ordinance in whole or in part.

Section Five: Nothing in this Ordinance shall authorize the District to refuse to provide any service to any person, business or entity that has not paid for services previously provided or that owes any money for services previously provided.

Section Six: That the provisions of this Ordinance shall be in full force and effect as of May 1, 2009.

Section Seven: That this Ordinance shall supersede any ordinances, resolutions or motions or parts of ordinances, resolutions or motions in conflict with any part herein, and any such ordinances, resolutions, or motions or parts of such are hereby repealed to the extent of any conflict.

Section Eight: If any section, paragraph or provisions of this Ordinance shall be held invalid or unenforceable for any reason, such invalidity or unenforceability shall not affect any of the remaining provisions of this Ordinance.
