**ORDINANCE NO. 2021-003**

**ORDINANCE LEVYING AND ASSESSING TAXES OF  
PALATINE RURAL FIRE PROTECTION DISTRICT  
COOK COUNTY, ILLINOIS FOR 2021**

**BE IT ORDAINED** by the Board of Trustees of the Palatine Rural Fire Protection District as follows:

**Section 1.** That the sum of **FOUR MILLION, SIX HUNDRED THIRTY TWO THOUSAND, FOUR HUNDRED AND THIRTY TWO DOLLARS (\$4,632,432.00)** assessed and levied from and against all taxable property within the limits of the said Palatine Rural Fire Protection District as the same is assessed and equalized for State and County purposes for the current year, 2021, and are to be applied in liquidation of the appropriations heretofore made by Ordinance adopted by the Board of Trustees of the Palatine Rural Fire Protection District at a meeting thereof regularly convened and held on December 13<sup>th</sup>, 2021, and duly published as provided by law, and the specific amount hereby levied is set forth under the column entitled "Amount To Be Raised By Tax Levy," as follows:

**Corporate Fund Levy** **\$ 1,686,876**  
The foregoing amount is hereby levied for general corporate purposes pursuant to 7- ILCS 705/14.

**Ambulance Fund Levy** **\$ 1,686,876**  
The foregoing amount is hereby levied for the purpose of providing emergency ambulance service under and pursuant to the provisions of 70 ILCS 705/22.

**Tort Liability Fund** **\$ 216,128**  
The foregoing amount is hereby levied for tort liability purposes under and pursuant to the provisions of 745 ILCS 10/9-107.

**Audit Expense Fund Levy** **\$ 8,083**  
The foregoing amount is hereby levied for audit expense purposes pursuant to the provisions of 50 ILCS 310/9.

**Social Security/IMRF Levy** **\$ 30,000**  
The foregoing amount is hereby levied for social security/IMRF purposes.

**Emergency & Rescue Levy** **\$ 421,719**  
The foregoing amount is hereby levied for Fire Rescue purposes.

**Firefighters' Pension Fund Levy – Cap Fund Portion** **\$ 276,967**

**Firefighters' Pension Fund Levy – Non-Cap Fund Portion** **\$ 305,783**  
The foregoing amounts are hereby levied for firefighters' pension purposes pursuant to 40 ILCS 5/4-118 (35 ILCS 200/18-185).
