**RESOLUTION MAKING A DETERMINATION
OF THE AMOUNTS OF MONEY ESTIMATED
TO BE NECESSARY TO BE RAISED BY TAXATION**

WHEREAS, the Truth in Taxation Law at 35ILCS200/18-60 requires a determination not less than 20 days prior to the adoption of the levy of the amount of money estimated to be necessary to be raised by taxation for property tax year 2021, to be received during calendar year 2022; and

WHEREAS, the Palatine Rural Fire Protection District (the "District") intends to comply with the Act.

NOW, THEREFORE, BE IT RESOLVED, as follows:

Section One: The District finds it necessary to raise \$1,680,560.00
in the Corporate Fund.

Section Two: The District finds it necessary to raise \$1,680,560.00
in the Ambulance Fund.

Section Three: The District finds it necessary to raise \$ 223,162.00
in the Tort Liability Fund.

Section Four: The District finds it necessary to raise \$ 8,346.00
in the Audit Fund.

Section Five: The District finds it necessary to raise \$ 27,675.00
in the Social Security/I.M.R.F. Fund.

Section Six: The District finds it necessary to raise \$ 655,490.00
in the Firefighter's Pension Fund.

Section Seven: The District finds it necessary to raise \$ 356,640.00
in the Emergency/Rescue Fund.

Section Eight: The District finds it necessary to raise \$ 285,000.00
in the Bond and Interest Fund.

Total: \$4,917,433.00

Section Nine: The District Board of Trustees hereby finds that a hearing will be required under the provisions of the Truth in Taxation Law, and that hearing shall be held at the November 8, 2021 Board of Trustees meeting.

Section Ten: This Resolution shall be in full force and effect upon its adoption and shall supersede any resolution or motions or parts of resolutions or motions in conflict with any part herein and any such resolutions or motions are hereby repealed.
