**ORDINANCE NO. 2017-003**

**ORDINANCE PROVIDING FOR BUDGET AND APPROPRIATIONS OF THE  
PALATINE RURAL FIRE PROTECTION DISTRICT  
COOK COUNTY, ILLINOIS FOR THE FISCAL YEAR  
BEGINNING JANUARY 01, 2018 AND ENDING DECEMBER 31, 2018**

**WHEREAS**, the Board of Trustees of the Palatine Rural Fire Protection District, Cook County, Illinois, caused to be prepared in tentative form a Budget and the Secretary of this Board made the same conveniently available for public inspection for at least thirty (30) days prior to final action thereon; and

**WHEREAS**, a public hearing was held as to such Budget on the 13<sup>th</sup> day of November, 2017 and Notice of said hearing was given at least thirty (30) days prior thereto as required by law.

**NOW, THEREFORE, BE IT ORDAINED** by the Board of Trustees of the Palatine Rural Fire Protection District ("District"), Cook County, Illinois, as follows:

**Section 1:** That the fiscal year of the Palatine Rural Fire Protection District ("District") is hereby fixed to begin on January 01, 2018, and to end on December 31, 2018.
